Notice Regarding the Mailing of National Health Insurance Eligibility Certificate

National Health Insurance Eligibility Certificate (hereinafter referred to as "Eligibility Certificate") is being mailed to individuals **who did not possess a My Number Card with registered health insurance functionality** (referred to as **"Myna Health Insurance Card"**) as of May 31, 2025. The newly issued certificate will be valid until July 31, 2026.

Please make sure to securely dispose of your old National Health Insurance Card or Eligibility Certificate. Take appropriate measures to protect your personal information during the disposal process. This notice is based on information available as of June 20, 2025.

Important Notice: Discontinuation of the Certificate of National Health Insurance Co-Payment Rate for the Elderly [*Korei Jukyushasho*] (For individuals aged 70 and over)

Starting August 1, the issuance of the Certificate of National Health Insurance Co-Payment Rate for the Elderly will be discontinued. The Eligibility Certificate being sent includes the co-payment rate and other benefit information previously shown on the certificate that is being replaced. Please use only the new Eligibility Certificate from August 1 onward.

Important information

- ① We encourage you to consider using your Myna Health Insurance Card
- Your co-payment limit information will be automatically integrated with your Myna Health Insurance Card. As a result, you will no longer need to carry the Certificate for Application of the Maximum Copayment Amount [*Gendogaku Tekiyo Ninteisho*], and renewal procedures will no longer be required.
- 2 If you are currently enrolled in Employee Health Insurance [*Shakai Hoken*] or another health insurance program, please complete the procedure to withdraw from the National Health Insurance
